ALL BIDS ARE TO BE SUBMITTED NO LATER THAN 2:00 PM ON THURSDAY NOVEMBER 7, 2024, AT WHICH TIME BIDS WILL BE OPENED AND READ PUBLICLY. Sealed Bids shall be identified on the outside of the envelope as “**Invitation to Bid – Kent County EMS Buildings**”. Sealed Bids are to be submitted to Kent County Department of Public Safety located at 911 Public Safety Boulevard, Dover, Delaware 19901.
